YOUR DESTINATION AIRPORT: WILL YOUR AIRCRAFT "FIT"??

Todd Scher will be the presenter at the Chapter 99 Membership meeting on Tuesday, May 11. The topic of the presentation is "Your Destination Airport – What to Expect". Pilots may assume that their destination airport can adequately handle their aircraft and their intended operations, but may also be surprised when it can't. Todd's presentation will show the many differences in airport facilities and features, how they might adversely affect your flight operation, and how to find out the information you need to keep surprises to a minimum!

FAASTEAM SEMINAR

The Treasure Coast FAA Safety Team (FAASTeam) will present its monthly safety Seminar at 7:00 PM on Thursday, May 19 at FlightSafety Main Hangar, Classroom M. The May seminar features David Littlefield, an Air Traffic Controller from Fort Pierce Tower. David is a CFI as well as a controller, which gives him the ability to understand issues and answer questions with the knowledge and experience gained from both sides of the microphone.

David gives a very entertaining presentation, and for those who have questions, is very approachable. This is a great opportunity to talk one-on-one with an air traffic controller who understands the pilot's perspective.

KVRB AIRPORT NEWS

Runway 11L-29R Rehabilitation Project – the airport expects to issue a Notice-to-Proceed to Ranger Construction on May 5, and construction on the project should begin shortly afterwards.

This project includes resurfacing of Runway 11L-29R, widening and resurfacing of Taxiway F, new runway and taxiway edge lights, new PAPI on Runway 11L, and stabilization of sandy soil at the Runway 29R approach end. The Taxiway F edge lights will be LED technology, which is expected to increase the life of the fixtures while using less electricity.

There will be numerous Runway and Taxiway closures associated with this project. Please get the latest NOTAMs before any flight...it only takes a few minutes at the most, and can save a lot of headaches (or worse!).

ARFF Vehicle – the Airport's new Rosenbauer Airwolf C-3 Aircraft Rescue and Firefighting Vehicle was delivered on Monday, April 14. The new "Crash 3" vehicle features FLIR (Forward-Looking Infrared Radar) which helps the operator aim the bumper nozzle, and can detect "hot spots" which might indicate an impending fire.
