▶ **Youth Guidance Kids See Their Dreams Take Flight on Sat. Sept. 17, 2011**

Alex made sure they all got a turn at the controls, and Keith again gave ground instruction in a Flight Safety classroom.

▶ **Airspaces - Presentation on Oct. 11, 2011**

The October 11th membership meeting will feature a presentation on Airspace, by Captain Robert Frangione. This presentation is a review of the different classes of airspace, the requirements for operations in each class, and some new and updated airspace information as well.

Captain Frangione is a FAASTeam Representative with the Treasure Coast FAASTeam, and is in his 50th year in the aviation industry. His extensive experience includes corporate and airline flying, and he is an ATP, CFII and MEI. Robert also holds a Masters Degree in Education.

MINUTES LAST MEETING

Minutes of the General Membership Meeting held on September 13, 2011, submitted by Alex W.

President Mike D. opened the meeting at 7:06 PM. There were 14 members and 1 guest present. Mike welcomed everyone to the meeting.

The Secretary's report was given by Alex W. He reported that the minutes to last month's meeting were published and distributed to the membership by email and in addition a copy is posted on the bulletin board on the back wall of the meeting room. He also asked for anyone that did not receive the e-mailed copy to let him know and he would get them a copy. He also asked all present to be sure and sign-in.

Treasurer Steve F. then gave the Treasurer's report indicating that there were no expenditures during the past month. He also reported that our banking now is with Wells Fargo since they took over Wachovia Bank's assets in our area.

Mike D. then welcomed our visitor to our Chapter and gave him the opportunity to introduce himself. He is Sean D., a new Piper employee and has begun construction of a KR-2 aircraft. He was welcomed with a round of applause.

Vice President Keith G. reported that the Vital Flight project has gone to the paint shop. He also inquired about EAA Chapter 99 stickers or decals that can be placed on the aircraft acknowledging the help given by the chapter in repairing and preparing it for display. Keith also reminded the chapter that there is again a push on to impose and raise user fees on general aviation aircraft. He also pointed out that an EAA chapter in Texas is raffling off a Cub replica for \$100 dollars per ticket and Sylvia P. has placed a flyer on the bulletin with the particulars on it. (See also LAST NOTES on page 3 for details!) He also reported that he has obtained approval to use one of the Flight Safety classrooms for the Young Eagles event next Saturday. A motion was made by Mike D. and seconded by Todd S., that we send \$100 to AOPA to help them in their fight against the user fees. The motion received unanimous approval by the members in attendance and the Treasurer was provided with contact information and authorized to send the check.

Webmaster Sylvia P. reported that she had overlooked sending an e-mail reminder to the membership about the meeting while she was out of town. She expressed her



apologies if anyone was missing out on the fun because of the lack of the reminder.

Mike D. then asked for builders reports. Ernie S., who is building a Barracuda, said that he had nothing new to report on his project. John H. reported that he has again changed his mind about what engine he will use on his Kitfox, and is now working on a diesel engine conversion. Ken M. reported that his Velocity XL project is progressing slowly, and most of his time is being spent at Velocity's facility and directed towards a new design for a five place, twin engine Velocity. He expects to begin hanging engines on it next week. It will utilize the IO-320 power plants producing 160 HP each. He expects the aircraft to be capable of takeoff with one engine. The design is expected to evolve into a turboprop powered eight passenger craft. A lot of interest has been generated on the velocity website and they are very enthusiastic in their outlook. Gerd P. had a question about an aircraft of that size flying in the experimental category and Keith G. noted that he had flown a Boeing 747 in the experimental category while testing a new radio installation for Qantas Airlines. Keith also reported that his project has not progressed lately but he would be getting back to work on it soon.

Mike D. then reminded the membership that the Chapter would be hosting a Young Eagles event on this Saturday, September 17, 2001 at our meeting room in conjunction with Chapter 908 from Fort Pierce. Chapter 908 is expected to bring 5 or 6 aircraft and Bill Z. is expected to be there also. Ken M. said that he also will be there. Chapter 99 will be providing ground support and anyone else who would like to fly Young Eagles is welcome to take part. It is expected that between twenty and thirty kids will take part. Ken M. reported that a reporter from the 32963 newsweekly would be here to cover the event also. Keith G. said that he has two students from Flight Safety who are going to help him with the classroom portion of the event over at Flight Safety. Mike D. said that he will be bringing orange juice, Keith G. and Alex W. agreed to bring donuts. Alex also will contact Gene G. to see if he will make pancakes. Todd S. will handle the aircraft parking and control, and the Fort Pierce Chapter will provide the registration paperwork for the event. Alex W. will have the Flight Simulator in operation.

Todd S. reminded everyone that the FFAST team seminar will be held Thursday night at 7PM in Flight Safety Classroom "M" and urged everyone to attend. He will be presenting a program about how pilots can be pressured to compromise their decision making, how to recognize it and what to do about it. He will also be discussing a runway incursion that occurred two weeks ago here at KVRB that he witnessed. He will cover how it evolved and what the parties involved could have done to prevent it.

Romeo V. informed the membership that an Erocoupe that was being restored by a Fort Pierce member who died, is now being offered for sale and encouraged anyone interested in it to contact the Fort Pierce Chapter 908.

There being no further business, a break for refreshments was taken.

After the break, Gerd P. discussed the replacement of the props on his Cessna 340. He covered the factors that governed his decisions about manufacturer and type of propeller and the changes in aircraft performance



that he has enjoyed since. After his comments everyone moved to his hangar to see the finished job and ask questions. From there the group moved to the box hangar where they admired Steve F's polish and paint job on his RV before adjourning at 9:00 PM.

AVIATION HUMOR

▶ **Proper Use of Tools ... Explained From a Safety Perspective of Course**

DRILL PRESS: A tall upright machine useful for suddenly snatching flat metal bar stock out of your hands so that it smacks you in the chest and flings your beer across the room, denting the freshly-painted project which you had carefully set in the corner where nothing could get to it.
